BRIEF OUTLINE OF EXPERIENCE

Mr. Wallace is a shareholder in Wallace & Gary Valuation Advisors, Inc. (W&G). He specializes in the valuation of business enterprises. He also provides litigation support services and expert witness testimony in connection with business valuation and economic damages.

Mr. Wallace is an Accredited Senior Appraiser (ASA) with the American Society of Appraisers. He was a CPA until recently and is on “retired” status with the California CPA Society. He is also an attorney on inactive status with the California BAR.

He has valued businesses for various purposes, including estate and gift tax, marital dissolutions, business dissolutions, business dissolutions under California Corporate Code Section 2000, merger and acquisition, business litigation, and eminent domain. The businesses and industries in which he has prepared valuations include agri-business, health care, professional service, manufacturing, distribution, asset holding companies, and technology.

Mr. Wallace has testified over 100 times in both federal and state courts on valuation, civil litigation and family law matters throughout California.

In connection with the estate and gift valuations performed by the firm, Mr. Wallace and W&G have successfully defended valuations—both those performed by W&G and other firms—before the Internal Revenue Service. He has also been engaged as a consultant by the Internal Revenue Service regarding valuation and discount methodology.

Prior to forming Wallace & Gary Valuation Advisors, Inc., in 1985 with his shareholder/partners, Mr. Wallace was a tax partner with Touche Ross & Co. (currently Deloitte).
